ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AUTHORIZING THE ACQUISITION OF FURNISHING AND EQUIPMENT FOR THE NEW BEACHWOOD VOLUNTEER FIRST AID SQUAD BUILDING AND APPROPRIATING THE SUM OF \$120,000.00 FROM THE BOROUGH OF PINE BEACH

BE IT ORDAINED by the Borough Council of the Borough of Beachwood,
County of Ocean and State of New Jersey, as follows:

SECTION 1. The improvements described in Section 2 of this Ordinance are hereby authorized to be undertaken by the Borough of Beachwood, in the County of Ocean and State of New Jersey. For said improvements as stated in Section 2, there is hereby appropriated the sum of \$120,000.00 which appropriation has been made available from the Borough of Pine Beach. The said sum was authorized pursuant to a Shared Services Agreement between the Borough of Beachwood and the Borough of Pine Beach in accordance with N.J.S.A. 40A:65-1, et seq.

SECTION 2. The description of the improvement required is a follow:

<u>Improvement</u>	<u>Appropriation</u>
Purchase of Furnishing and Equipment for The New Beachwood Volunteer First Aid Squad Building	\$120,000.00

SECTION 3. The capital budget of the Borough of Beachwood is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The Resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

SECTION 4. This Ordinance shall take effect twenty (20) days after the first publication thereof after final adoption as provided by said Local Bond Law.

NOTICE

The Ordinance published herewith was introduced and passed upon first reading at a meeting of the Borough Council of the Borough of Beachwood, Ocean County, New Jersey held on the 3rd day of August , 2009. It was further considered for final passage, after public hearing thereon, at a meeting of said Borough Council to be held at the Beachwood Municipal Complex, 1600 Pinewald Avenue, Beachwood, New Jersey on the 19th day of August , 2009 at 7:00 p.m. and during the week prior to and up to and including the date of such meeting, copies of said ordinance were made available at the Clerk's Office in said Borough Hall to the members of the general public who requested the same.

STATEMENT

The Bond Ordinance published herewith has been finally adopted and the twenty (20) day period of limitation within which a suit, action or proceeding questioning the validity of such ordinance can be commenced, as provided by the Local Bond Law, has begun to run from the date of the first publication of this statement.
