

ORDINANCE 2013-11

ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY PROVIDING FOR A SUPPLEMENTAL APPROPRIATION OF \$40,845.34 FOR IMPROVEMENTS TO THE MUNICIPAL BUILDING APPROPRIATING SAID SUM FROM THE BOROUGH'S BUDGET UNDER THE "RESERVE FROM INSURANCE PROCEEDS" IN SAID AMOUNT

BE IT ORDAINED by the Borough Council of the Borough of Beachwood, County of Ocean and State of New Jersey, as follows:

SECTION 1. The improvements described in Section 2 of this Ordinance are hereby authorized to be undertaken by the Borough of Beachwood, in the County of Ocean and State of New Jersey. For said improvements as stated in Section 2, there is hereby appropriated the supplemental amount of \$40,845.34, said sum being in addition to the \$65,000 appropriated by Beachwood Borough Ordinance 2011-10 duly adopted on October 5, 2011 and including the sum of \$65,000 from the Beachwood Borough Capital Improvement Fund.

SECTION 2. The description of the improvement required is as follows:


Improvement	Appropriation
Improvements to the Municipal Building	\$65,000.00
Supplemental Improvements to the Municipal Building	\$40,845.34

SECTION 3. This Ordinance shall take effect twenty (20) days after the first publication thereof after final adoption as provided by said Local Bond Law.


