

**ORDINANCE 2015-03**

**ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER IX ENTITLED "RECREATIONAL FACILITIES" TO SUPPLEMENT SUBSECTION 9-4.2 (MISCELLENEOUS RECREATION FEES)**

**BE IT ORDAINED** by the Borough Council of the Borough of Beachwood, County of Ocean and State of New Jersey, as follows:

**SECTION 1.** Section 9-4.2 of the Code of the Borough of Beachwood is hereby supplemented to include the following subsection:

"9-4.2 (d) Yoga or Special Exercise Instruction with fee per person per session or class \$5.00 to \$10.00.

- (i) Fee per class or session to be set by the Governing Body of Beachwood as referenced above on May 1 of each year.
- (ii) The instructor shall be paid the established fee less 20% to be retained by the Recreation Trust Fund of Beachwood.

**SECTION 2.** This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

**SECTION 3.** If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect, and for this purpose the provisions of this Ordinance are hereby declared to be severable.

**SECTION 3.** This Ordinance shall take effect immediately upon its final passage and publication as required by law.
