

**ORDINANCE 2019-06**

**ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER IX ENTITLED "RECREATIONAL FACILITIES" TO SUPPLEMENT SUBSECTION 9-4.2 (MISCELLENEOUS RECREATION FEES)**

**BE IT ORDAINED** by the Borough Council of the Borough of Beachwood, County of Ocean and State of New Jersey, as follows:

**SECTION 1.** Section 9-4.2 of the Code of the Borough of Beachwood is hereby supplemented to include the following:

(1) The following field use fees are established for various recreational programs within the Borough of Beachwood:

a. Recreation Sponsored Events: Fees for recreation sponsored special events shall be established on May 1<sup>st</sup> of each year by resolution duly adopted by the Beachwood Borough Council and falling within the following (fees not to exceed):

(d) Yoga or Special Exercise Instruction with fee per person per session or class \$5.00 to \$10.00.

(i) Fee per class or session to be set by the Governing Body of Beachwood as referenced above on May 1 of each year.

(ii) The instructor shall be paid the established fee not to exceed \$40.00 per 1 hour session.

(e) Running Clinic with fee per person as \$50.00

(i) Fee per class or session to be set by the Governing Body of Beachwood as referenced above on May 1 of each year

(ii) Fees to be paid to Running Clinic Instructors shall be within the following range:

Running Clinic Instructor: \$15.00-\$25.00 per session

**SECTION 2.** This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

**SECTION 3.** If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect, and for this purpose the provisions of this Ordinance are hereby declared to be severable.

**SECTION 4.** This Ordinance shall take effect immediately upon its final passage and publication as required by law.
