6. Events Schedule

- a. 2015 Event Planning
 - i. Tennis

1. McNabb reported on the final tennis practice on July 11 at Jake's Branch Park. Three courts were reserved for the children, and a 90 minute session included drills, games and match play. The session was followed by a pizza party in the picnic area, to include
