

RESOLUTION 2015-451

RESOLUTION OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AWARDING A CONTRACT TO EARLE ASPHALT FOR THE 2015 CAPITAL PROGRAM IN THE LOW BASE BID AMOUNT OF \$712,013.13 AND THE LOW ALTERNATE BID "A" IN THE AMOUNT OF \$161,600.00 FOR THE TOTAL BID AMOUNT OF \$873,613.13

WHEREAS, the Borough of Beachwood previously authorized receipt of bids for water filter replacement; and

WHEREAS, at the time and place for the receipt of bids four (4) bids were received ranging from a low base bid amount of \$712,013.13, and low alternate bid "A" in the amount of \$161,600.00 for a total of \$873,613.13, to a high base bid amount of \$1,029,209.85, and alternate bid "A" in the amount of \$276,441.25 for a total of \$1,305,651.10; and

WHEREAS, the Borough's Engineers, T&M Associates, have reviewed said bids and recommended the award to Earle Asphalt in the low base bid amount of \$712,013.13 and low alternate bid "A" in the amount of \$161,600.00 for a total of \$873,613.13; and

WHEREAS, the Borough's Chief Financial Officer has certified that funds are available to award said contract; and

WHEREAS, it is the desire of this Governing Body to act upon the Engineers recommendation and award a contract for water filter replacement.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Beachwood, County of Ocean and State of New Jersey as follows:

1. That the Borough Council hereby awards a Contract to Earle Asphalt for 2015 Capital Program in the base bid amount of \$712,013.13 and alternate bid "A" in the amount of \$161,600.00 for a total of \$873,613.13 in accordance with the Borough Engineers' bid specifications.
2. That upon the adoption of the within resolution, the Borough Clerk is authorized to forward a certified copy of it to the Borough CFO, the Borough Treasurer, the Borough Engineer.
