ORDINANCE OF THE BOROUGH OF BEACHWOOD, OCEAN COUNTY, NEW JERSEY AMENDING CHAPTER XV ENTITLED, "WATER" TO MODIFY THE WATER RATES TO EXCLUDE CERTAIN SWIMMING POOL CHARGES

BE IT ORDAINED by the Borough Council of the Borough of Beachwood,

County of Ocean and State of NewJ ersey, as follows:

SECTION 1 Section 15-1.9 of the Code of the Borough of Beachwood entitled, "Rates and Charges", is hereby amended to delete subsection c reading:
"When a swimming pool is filled with municipal water by any person authorized by the Water Department, from a source other than the resident's own metered service, the charge will be seventy five ( $\$ 75.00$ ) dollars."

SECTION 2. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

SECTION 3. This Ordinance shall take effect immediately upon its final passage and publication as required by law.
